Topic: Lecture on Women's Rights

At S.D. College Hoshiarpur, the Women Grievance cell organised an expert lecture on rights for women by Advocate Sh. Sanjeev Kumar from the Department Law. He recounted the history of the day to spread awareness of women's rights, gender equality and empowerment. He pointed out that despite huge contribution of women to the betterment of society, they were discriminated in every sphere of life.

Women's rights are the rights and entitlements claimed for women and girls worldwide, and which formed the basis for the women's rights movement in the 19th century and feminist movement during the 20th century. In some countries, these rights are institutionalized or supported by law, local custom, and behavior, whereas in others they are ignored and suppressed. They differ from broader notions of human rights through claims of an inherent historical and traditional bias against the exercise of rights by women and girls, in favour of men and boys.

Issues commonly associated with notions of women's rights include the right to bodily integrity and autonomy; to be free from sexual violence; to vote; to hold public office; to enter into legal contracts; to have equal rights in family law; to work; to fair wages or equal pay; to have reproductive rights; to own property; to education.

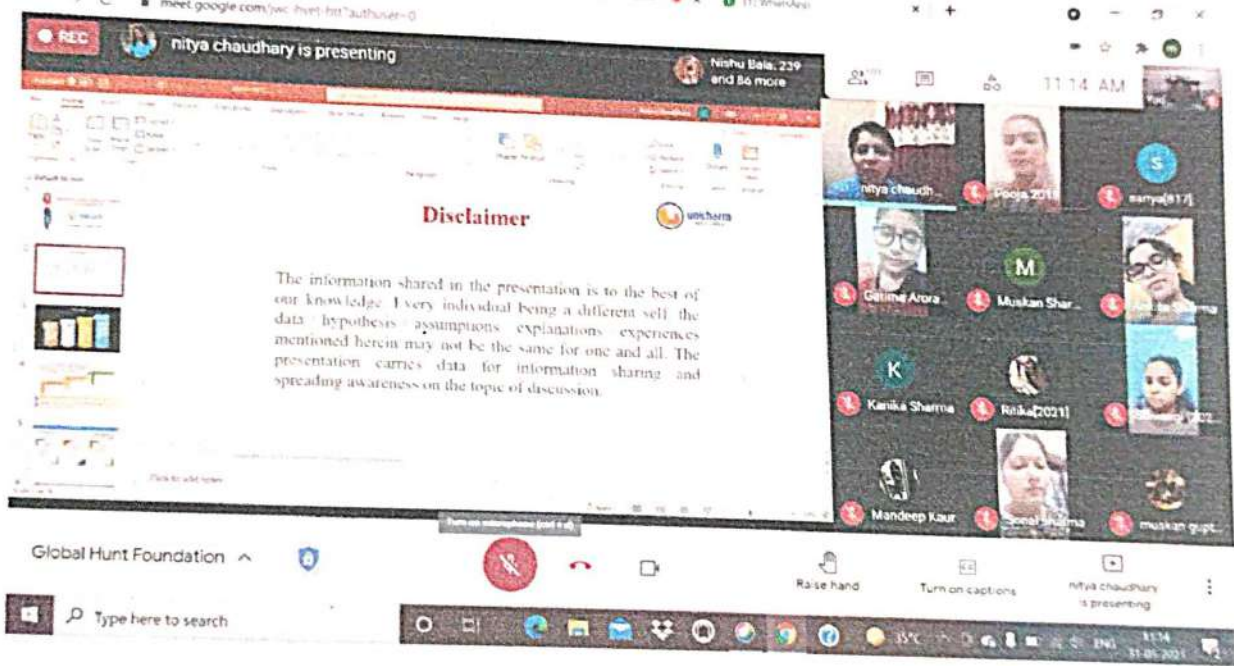

- 01 Use of clean and soft absorbent sanitary products & change sanitary napkins at regular intervals
- 02 Take bath at least once a day, even during periods & keep the area between the legs dry and clean
- 03 Use of clean and dry undergarments and change those daily & dry undergarments under the Sun
- 04 Wash the genital area with plain water (no soap) every time you use the toilet (also after urination). Avoid using any fragranced cream or lotion around the vaginal area
- 05 Always wash from front to back after defecation
- 06 Wash hands before and after changing sanitary napkins. Use cotton panty during menstruation
- 07 Use a clean toilet or use an Indian toilet at public areas as these have lower incidence of spreading RTI
- 08 Store sanitary napkins in clean and dry place

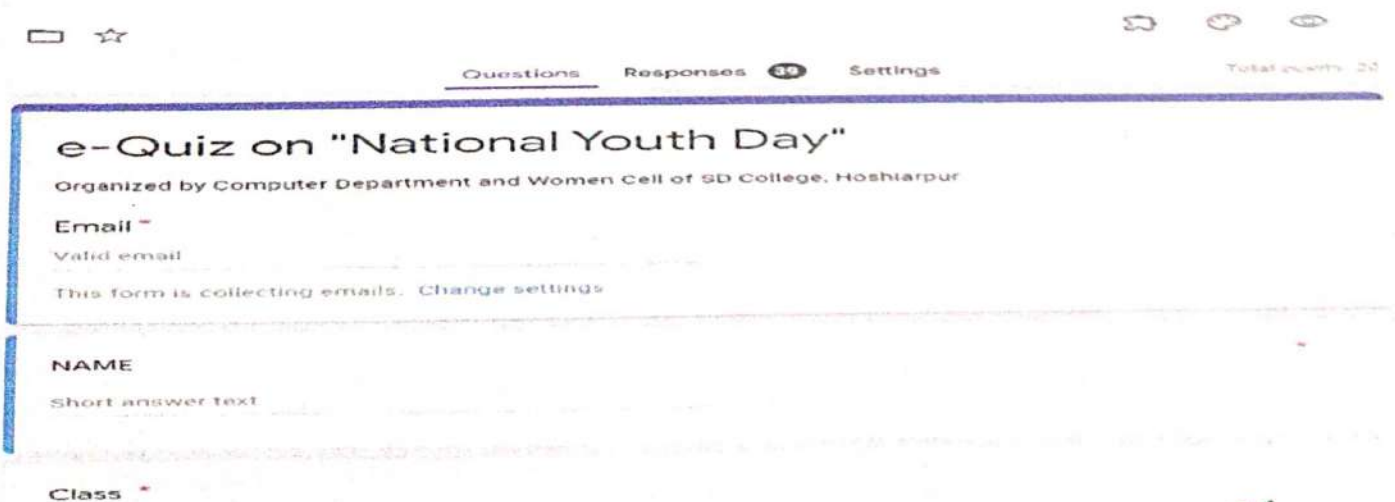


Topic : eQuiz competition on National Youth Day(12/01/2022)

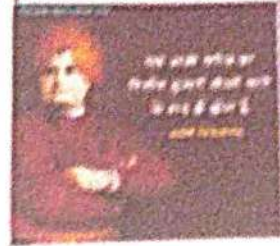

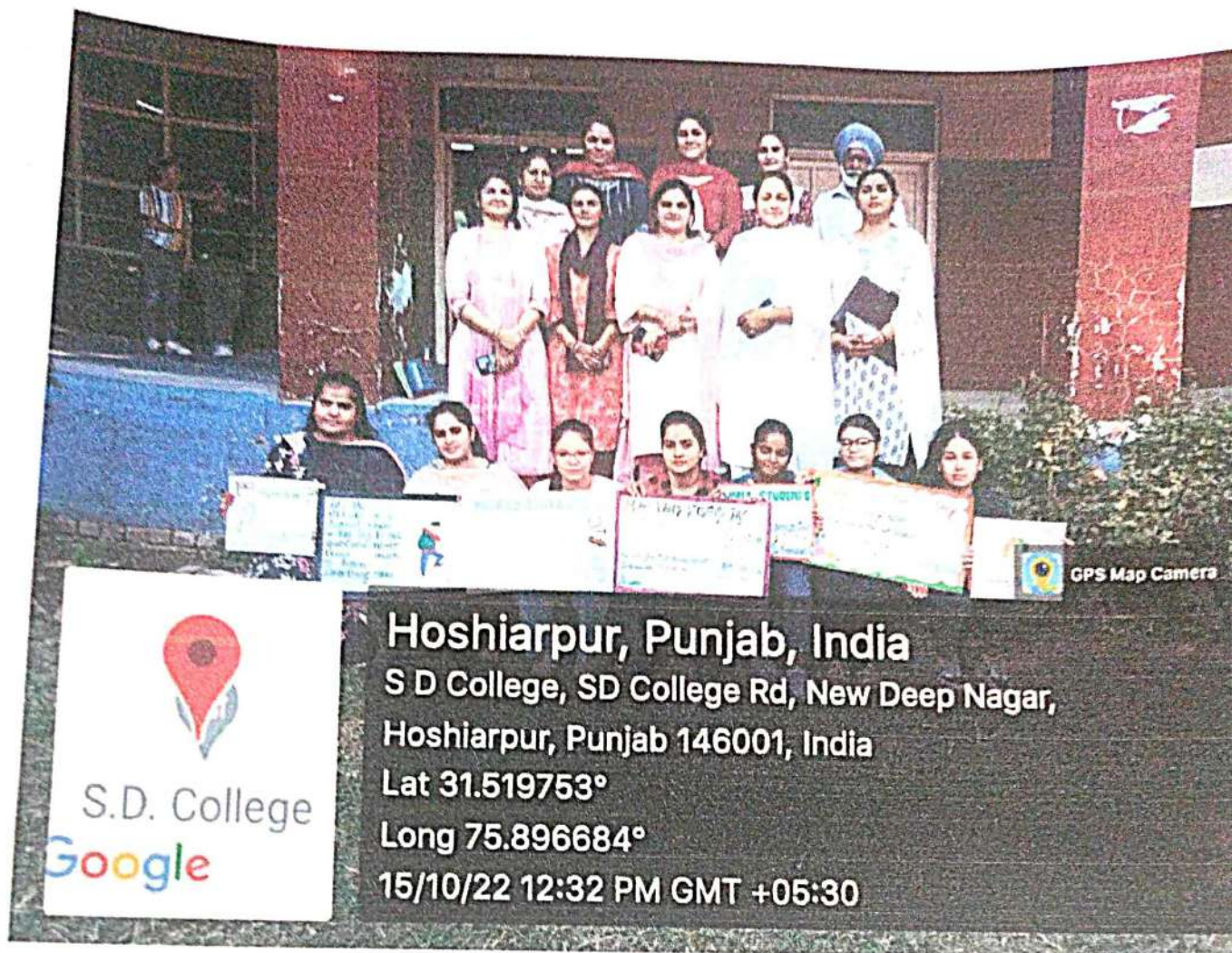

This committee is functional with the principal as the head, vice principal, two faculty members. Anti-Ragging committee should be one of the important parts of Educational Institution's mechanism. As per the guidelines of UGC under the Act of 1956, which is modified as UGC regulations on curbing the menace of Ragging in higher Educational Institutions, 2009, establishment of Anti-Ragging Cell is very compulsory.

As per the order of Supreme Court of India and subsequent Notification from University Grants Commission (UGC), ragging constitutes one or more of any intention by any student or group of students on:

1. Any act of Indiscipline, Teasing or Handling with Rudeness.
2. Any act that Prevents, Disrupts the Regular Academic Activity.
3. Any activity which is likely to cause Annoyance, hardship, Psychological Harm or creates Fear or Apprehension.
4. Any Act of Financial Extortion or Forceful Expenditure.
5. Any Act of Physical Abuse causing Assault, Harm or danger to Health.
6. Any Act of abuse by spoken words, emails, SMS or public insult etc.
7. Any Act of injury or infringement of the fundamental right to the human dignity.
8. Any Act of Wrongful Confinement, Kidnapping, molesting or committing unnatural offences, use of criminal forces, trespass or intimidation.
9. Any unlawful assembly or conspiracy to ragging.

Punishment to those found guilty

Any student or group of students found guilty of ragging in the campus or even outside the campus shall be liable to one or more of the following punishments.

1. Debarring from appearing in any sessional test / University Examination
2. Suspension from attending classes and academic privileges
3. Withdrawing scholarships and other benefits
4. Suspension from the college

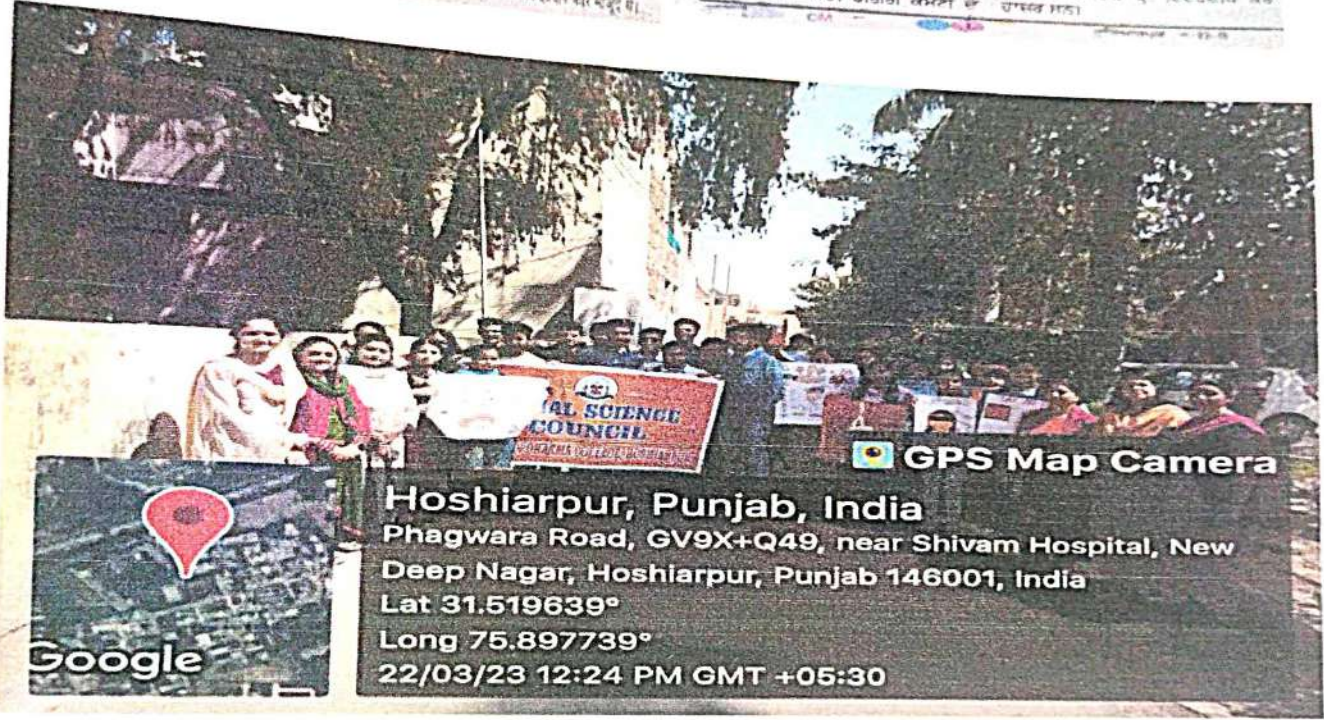

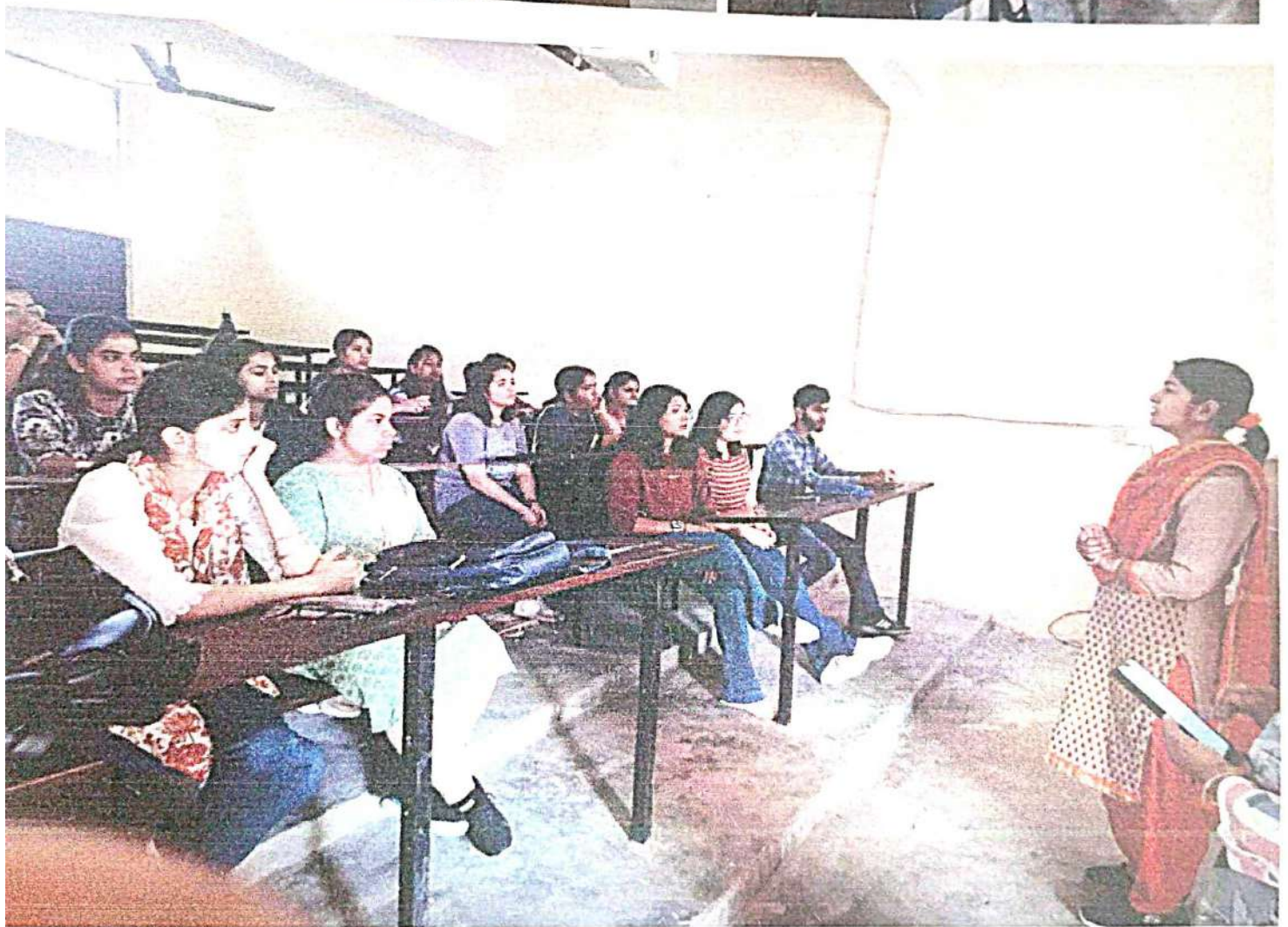
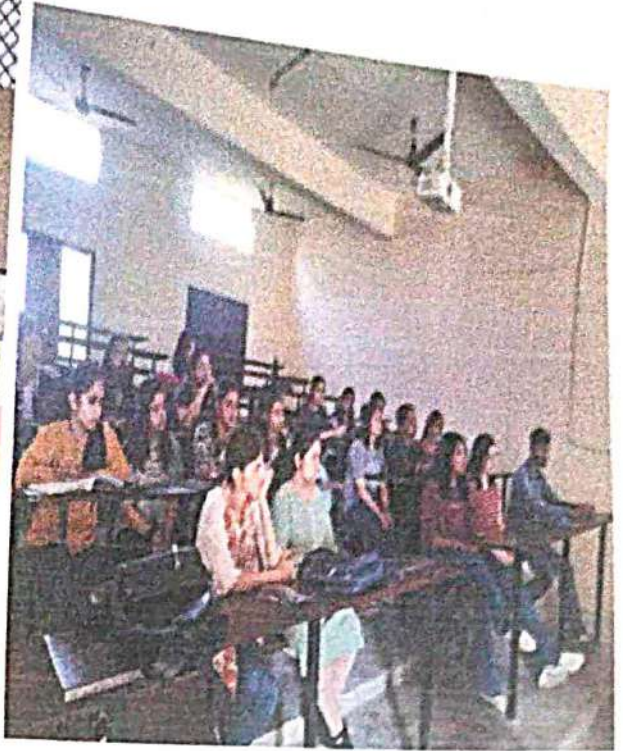
